This administration announces a tender for a negotiated procedure pursuant to arts. 36, paragraph 2, letter b) and 95 of Legislative Decree 50/2016.

Pursuant to art. 95, paragraph 3 of Legislative Decree 50/2016, the awarding of the tender will take place with the criterion of the most economically advantageous bid.

Pursuant to art. 95, paragraph 7 of Legislative Decree No. 50/2016, the element relating to cost will take the form of a fixed cost on the basis of which the economic operators will only act on the basis of qualitative criteria.

The compensation due to the winning bidder will follow the requirements set out in the specifications of the tender.

## SUBJECT OF THE CONTRACT

The tendering procedure aims to entrust the service of the b2b PROMO-COMMERCIAL CAMPAIGN IN RUSSIA AIMED AT THE POSITIONING OF THE HOLIDAY GLOBAL DESTINATION "EMILIA-ROMAGNA" ON THE RUSSIAN OUTBOUND TRAVEL INDUSTRY MARKET. For further specifications, refer to the specifications of the tender.

## AMOUNT AND DURATION OF THE CONTRACT

The contract will be stipulated with the economic operator who will obtain the highest score, following the evaluation of the offer based on qualitative criteria. The maximum bid amount will be € 180,000.00 plus 22% VAT, if due.

The cost of labour is estimated to be  $\in$  0, considering that the service object of the tender relates to intellectual work and does not imply any supplies with installation. The contract will have duration from the stipulation until 31.12.2018, with a renewal option for one more year under the same conditions, for the same offer, at the same cost.

The value of the first year is € 90,000.00 plus VAT 22% if due.

The value of the optional second year is € 90,000.00 plus VAT 22% if due.

The total value of the procedure is € 180,000.00 plus VAT 22% if due.

The service will be carried out outside the contracting entity's premises exclusively by the staff of the awarded contractor, who are not an employees of the contracting entity - APT Servizi. Therefore, the costs of security from interference at the charge of the contracting entity - APT Servizi - are equal to  $\in 0$ .

## SUBJECTS ADMITTED TO THE SELECTION

All the economic operators referred to in art. 45 of Legislative Decree no. 50/2016, meeting the requirements here below indicated, can express the interest to participate in the tender.

The economic operators headquartered in other member states of the European Union, established in accordance with the legislation in force in the respective countries, as well as the economic operators headquartered in third countries signatories of the agreements pursuant to art. 49 of Legislative Decree 50/2016, are allowed to participate in the procedure under the conditions and in the manner provided for in articles 45, 49, 83 and 86 of Legislative Decree 50/2016, through the production of equivalent documentation, according to the regulations in force in the respective countries.

The tender, under penalty of exclusion, is reserved to the following type of economic operator:

• air charter brokers with a tour operator / travel agency license

The air charter broker with a tour operator/organizer license is a company that operates exclusively in the wholesale supply chain of the travel industry. It is the charterer who rents aircrafts with crew from airlines. Through the charter contract, the air charter broker with a license of tour operator / organizer purchases the entire capacity of the aircraft and resells it, in blocks of seats, to other tour operators, which in turn sell, directly online or indirectly through retail travel agencies, to consumer some complete holiday packages - that include return flight travel, accommodation, ground transportation, guided tours, etc. To carry out this trade, the air charter broker must have a tour operator / travel agency authorization defined and identified by the legislation in force in the country where the company has its headquarters.

The tender, under penalty of exclusion, is reserved only to air charter brokers who:

- arrange and wholesale seasonal or annual public charter flights from Russian cities to one or more of the three International airports in Emilia-Romagna region (Rimini, Bologna and Parma);
- ✓ directly assume the economic and business risk deriving from the organization and wholesale trade of seasonal or annual public charter flights from Russian cities to one or more of the three International airports in Emilia-Romagna region (Rimini, Bologna and Parma);
- ✓ have provided similar services to that object of the tender for a minimum of € 90,000.00 plus VAT 22% if due in the last three years from the date of publication of this notice.

The following economic operators are excluded from the tender:

- Representative offices and marketing and communication agencies, even if they are owned by the tour operator and are authorized to act in the name and on behalf of the tour operator, because those parties do not bear the business risk.
- 2. The economic operators who have applied for a contribution to the Emilia-Romagna Region and obtained the approval of the same, with reference to Regional Law nr 4/2016 art. 5, paragraph, 4 letter c) "Contributions to tourism promo-marketing projects carried out by companies also in an associated form".

All the above requirements are mandatory; applicants that lack one or more of them will be rejected.
