- Annual activity plan

2. <u>Overall quality of the agency, level of experience and expertise of the agency and the project team</u> will be evaluated through these 3 elements and 3 related documents

 Experience in the communication sector, PR, MR, press office and in the management of tourism promotion campaigns for DMOs (related document -> company profile)

4. Overall economy of services.
