MARKET INVESTIGATION NOTICE AIMED TO THE DIRECT AWARD OF PR, COMMUNICATION AGENCY AND PRESS OFFICE SERVICES FOR THE WHOLE TOURIST DESTINATION "EMILIA ROMAGNA", ON THE POLISH MARKET, PURSUANT TO ART. 1, PARAGRAPH 2, LET. A), OF L. D. 76/2020 (CONVERTED WITH MODIFICATIONS BY LAW 120/2020) CIG/CONTRACT IDCODE -ZC130C259E

Subject of the direct award: PR & MR agency, communication and press office services for the whole tourist destination *Emilia Romagna* on the Polish market in the year 2021.
